



Position Opening Notice Cosmetology Adjunct Instructor (Part-time)

College and Area Information: Eastern Arizona College's District Offices are located in Thatcher, Arizona, a beautiful rural area with easy access to arid as well as mountainous recreation. The College is located approximately 125 miles northeast of Tucson and 165 miles southeast of Phoenix. EAC is a comprehensive community college offering five associate degrees across nearly 50 programs of study. Eastern Arizona College is the oldest member of the Arizona Community College system and is fully accredited by The Higher Learning Commission of NCA.

Organizational Relationship: The Part-time Cosmetology Instructor reports to the Director of the Cosmetology Program.

Required Qualifications:

- State of Arizona licensed cosmetology instructor
- Ability to relate effectively with students from a wide variety of ethnic backgrounds, learning orientations, and levels of preparedness
- Ability to work well within a departmental structure and with other faculty and staff in the design and implementation of curriculum and assessment protocols
- Effective organizational and recordkeeping skills

Preferred Qualifications:

- Teaching experience in cosmetology
- Computer literate with experience using computers for supplemental and mediated instruction
- A clear understanding of and commitment to the community college philosophy and goals

Responsibilities:

- Teach a variety of cosmetology courses and provide effective guidance and supervision of students during hands on training on the floor.
- Teach no more than nine (9) contact hours a week, that includes Saturday hours, for approximately 11 months a year.
- Courses and floor supervision may be offered at various times including morning, afternoon, and evening schedules.
- Be available for consultation with colleagues, attend mandatory meetings, and complete training and other assignments as required.
- Perform other duties as assigned.
